Index Description

The Solactive China Financials Index is designed to reflect the performance of the financials sector in China. It is comprised of selected companies which have their main business operations in the financials sector and are domiciled in China or have their main business operations in this country. Only securities which are tradable for foreign investors without restrictions are eligible.

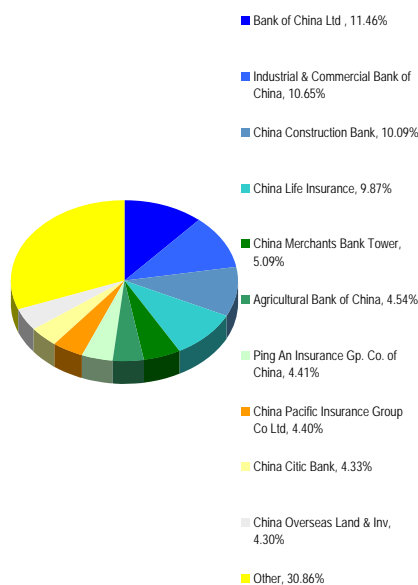

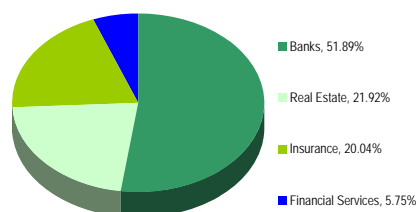
